



## ROAD TRAFFIC REGULATION ACT 1984

### COMHAIRLE NAN EILEAN SIAR STORNOWAY TOWN CENTRE (PROHIBITION OF WAITING) ORDER 2008 AMENDMENT (NO 2) ORDER 2016

TRO-16/02

Comhairle nan Eilean Siar in exercise of its powers under the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) and of all other powers enabling it in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order:

1. This Order may be cited as the “Comhairle nan Eilean Siar Stornoway Town Centre (Prohibition of Waiting) Order 2008 Amendment (No 2) Order 2016” and shall come into operation on <<DATE TBC>>.
2. The Comhairle nan Eilean Siar Stornoway Town Centre, (Prohibition of Waiting) Order 2008 (“the 2008 Order”) shall be amended as follows:

(a) In Schedule 1 of the 2008 Order:

- (i) Amend entry ‘5a’ by deletion of the number 10 where it appears in the second line of the entry and substitution of the number 35 therefor.
- (ii) Amend entry ‘5j’ by deletion of the number 10 where it appears in the second line of the entry and substitution of the number 35 therefor.

(iii) After entry ‘5q’, insert:

“5r		<i>South side from the extended west kerbline of Elizabeth Haldane Court for a distance of 30 metres or thereby, westward.</i>
5s		<i>South side from the extended east kerbline of Elizabeth Haldane Court for a distance of 13 metres or thereby, eastward.”</i>

- (iv) Amend entry ‘6a’ by deletion of the number 13 where it appears in the second line of the entry and substitution of the number 23 therefor.
- (v) Amend entry ‘7b’ by deletion of the number 8 where it appears in the second line of the entry and substitution of the number 31 therefor.
- (vi) Amend entry ‘12d’ by deletion of the number 27 where it appears in the second line of the entry and substitution of the number 130 therefor.
- (vii) Delete entry 12e.

(viii) After entry ‘29b’ insert:

“30a	<i>Elizabeth Haldane Court</i>	<i>West side from extended south kerbline of Church Street for a distance of 15 metres or thereby, southward.</i>
30b		<i>East side from the extended south kerbline of Church Street for a distance of 15 metres or thereby, southward.</i>
31a	<i>South Beach Quay</i>	<i>On the South side of the access to the ferry car park from the ‘herring girl’ statue for a distance of 98 metres or thereby, eastward.</i>
31b		<i>On the North side of the access to the ferry car park from a point 8 metres of the extended south kerbline of South Beach Street for a distance of 100 metres or thereby, southwards and then eastward.”</i>

- (b) In Schedule 2:
  - (i) Delete entries '1d' and '1f' and '2a' from the Schedule.
- (c) In Schedule 3:
  - (i) Delete entries '1a', '1b' and 5c.
  - (ii) Amend entry '3a' by deletion of the number 134 where it appears in the second line of the entry and substitution of the number 124 therefor.
- (d) In Schedule 4
- (e) In Schedule 5

After entry '9' insert:

"10	South Beach Quay	West to East

- (f) **Minor and consequential amendments**
  - (i) Amend Article 5(o) of the 2008 Order, by deletion of the number "1997" and substitution of the number "1999" therefor.
  - (ii) Amend the preamble of Schedule 6 to the 2008 Order by deletion of the number 2012 where it appears at the end of the clause and substitution of the number "2013" therefor.
  - (iii) Amend Article 2(f) of the 2008 Order by deletion of "Plan 3" where it occurs prior to the word "annexed" and substitution of the word "Plan" therefor.
  - (iv) Delete Article 2(e) of the Stornoway Town Centre (Prohibition of Waiting) Order 2008 (Amendment No 1) (Bayhead and Scotland Street) Order 2013.
