COMHAIRLE NAN EILEAN SIAR
STORNOWAY TOWN CENTRE (PROHIBITION OF WAITING) ORDER 2008
(AMENDMENT NO 1)
(BAYHEAD AND SCOTLAND STREET) ORDER 2013

Comhairle nan Eilean Siar in exercise of its powers under the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other powers enabling it in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order:

- 1. This Order may be cited as the "Comhairle nan Eilean Siar Stornoway Town Centre (Prohibition of Waiting) Order 2008 (Amendment No 1) (Bayhead and Scotland Street) Order 2012" and shall come into operation on [date].
2. The Comhairle nan Eilean Siar Stornoway Town Centre. (Prohibition of Waiting) Order 2008 ("the 2008 Order") shall be amended as follows:

- (a) In Schedule 5 of the 2008 Order after item 8 specified therein shall be inserted the following:

Table with 3 columns: Item number, Description of road, and Direction. Row 1: "9", "Scotland Street from its junction with Kenneth Street to its junction with Keith Street", "West to East"

- (b) Paragraph 2(e) of the 2008 Order shall be amended by insertion of the words "all as" being inserted between the words "road" and "specified" where they occur in the first line thereof;
(c) After Paragraph 2(e) of the 2008 Order there shall be inserted the following: "(f) No person shall park any motor vehicle for longer than 8 hours between the hours of 8am and 6pm on any day and shall not return within 2 hours of departure on the lengths of road specified in Schedule 6 to this Order and illustrated by pink lines marked on the Plan 3 annexed and subscribed as relative hereto."
(d) after Schedule 5 to the 2008 Order there shall be inserted the Schedule 6 referred to in paragraph 2(c) hereof which Schedule is annexed and subscribed as relative hereto and deemed hereby to form Schedule 6 to the 2008 Order.
(e) The provisions of paragraph 2(a) and 2(c) hereof are illustrated on the 'Plan 3' annexed and subscribed as relative hereto which plan shall be held to be incorporated in the 2008 Order.
(f) Paragraph 3 of the 2008 Order shall be amended as follows: the words and figures "Clauses 2(a)-(e)" where they appear in the first line of that Paragraph shall be delete and the words "Clauses 2(a)-(f)" shall be substituted therefore.
