Matters Arising:

Bus Shelters: on schedule for repair.

<u>Coastal Communities Fund</u>: All local groups in the forum area had been successful, and letters will go out shortly. Thanks to both Councillors for their work on this.

Traffic Issues: Cllr Fraser will check regarding the 30mph signs. The Roads department was currently working in South Uist, so this might mean a delay. Tour buses are reported to be staying away from Callanish as requested.

<u>Renewables</u>: Aquatera had reported on their consultation on Community benefit. Further consultations by Northlands were organised for June.

Correspondence:

<u>Resignation:</u> An email was received from Lorraine Ballantine intimating her resignation from the Community Council. The members expressed their thanks for her service.

Care Home: Jenny Morrison informed the group of her experience supporting her friend through the move from Blair Bhuidhe to Bremner Court, and the many problems they encountered. Members were concerned to hear about the situation, particularly the fact that residents who had been assessed as requiring 24 hr nursing care were now considered tenants of HHP. It was unclear what the implications would be for their savings and whether the residents would be disadvantaged.

It was decided to invite Nick Fayers from the IJB and Emma Macsween from CnES to the next meeting to clarify some of the issues and answer questions.

<u>Tourist Activity</u>: It was reported that visitors to the standing stones had been using the surrounding crofts for toileting purposes. Members agreed this was unacceptable and there was no excuse for such behaviour. Cllr Fraser had had signs made stating there were no toilet facilities, and would pass them on to the crofters concerned.
