QUESTIONS

Written Questions to the Convener and Chairmen of Committees

The following written question was submitted by Mr Calum Maclean:

"At last week's Education Committee meeting there was a debate on the recent HMIE Report on The Nicolson Institute. At that meeting, I asked what the term VC stood for within the Report and was informed that it meant Virtual Comparator. Would you say that Anderson High School in Shetland was a Virtual Comparator for The Nicolson Institute".

The Convener responded as follows:

A Virtual Comparator (VC) is, by definition, a virtual cohort of pupils used for comparison purposes and is not comparable with any other actual school. VC is a methodology used for schools to allow for an analysis of comparative performance, usually in attainment, and it is created by using the demographics of the particular school to match learners with the same characteristics from across the nation to create a 'virtual' school that is as close as possible to the one being compared. It is not possible to use a VC to draw meaningful comparison between The Nicolson Institute and Anderson High or any other specific school in Scotland. You can only compare a school to its own virtual comparator.

The Convener asked Mr Maclean if he had a supplementary question.

Mr Calum Maclean responded as follows:

The Scottish Government produces attainment figures for Secondary Schools and in that they produce a table that itemises Schools that have dropped 50 places over a period of time (that time limit is about 5 or 6 years). The comparator table compares Schools that have 5+ Highers in their leaving cohort and the three Western Isles Schools are found in the bottom ten. In view of that data and the three last HMIE Schools that have been inspected having Weak, Satisfactory and Good, that along with what we hear about teaching morale, do you think that we should be concerned about how education has changed in our islands over the past few years?

The Convener informed Mr Maclean that he would get a response to his supplementary question, in due course.

COMHAIRLE NAN EILEAN SIAR: 15 FEBRUARY 2024

The following written question was submitted by Ms Susan Thomson:

"Would the Convenor provide an update on the Major Projects Forum, its work, scope, membership, and information on what the Comhairle's role is and how and to whom it reports?"

The Convener responded as follows:

"Over the next decade there will be an unprecedented level of renewable energy investment in the Outer Hebrides, which will include:

a 1.8GW HVDC interconnector, sub-station and supporting infrastructure to be constructed by Scottish and Southern Energy Networks;

depending on final build-out, circa 450MW of terrestrial on-shore wind; depending on the achievement of relevant consents and final build-out, circa 2.8GW of Offshore Wind;

construction of a "Net Zero" green hydrogen production hub(s)

This will represent the largest ever private sector investment into the Outer Hebrides and will coincide with a further series of investments, such as the activity being delivered through the Islands Growth Deal and Levelling Partnership by the UK and Scottish Governments.

The initial membership of the Major Development Forum comprises of:

- the key renewable energy developers
- Scottish and Southern Energy Networks
- · Comhairle nan Eilean Siar
- · Highlands and Islands Enterprise
- University of the Highlands and Islands

Other bodies may be asked to join the Forum as the process matures, as activity dictates and as a workplan develops.

The Forum is a Technical Officer Working Group that seeks to implement agreed Comhairle policy. It is chaired by the Comhairle (Depute Chief Executive) and will report to the Sustainable Development Committee as required."

The Convener asked Ms Thomson if she had a supplementary question.

Ms Thomson responded as follows:

Could we have a Report to the next series of meetings on this matter?

The Convener confirmed that a Report would be submitted on this matter, at the earliest opportunity.

"That the council agree that:

- (1) the lower floor of St Lennan's be used as the Outer Hebrides Bairns Hoose subject to the Chief Executive/Chief Social Work Officer committing to a process of formal consultation with the current organisations/users utilising the much-valued ground floor of the St Lennan's centre, as regards any process formulated by the Chief Social Work Officer on the venue proposed by him for future use of the St Lennan's centre;
- (2) the Chief Executive/Chief Social Work Officer advise all members of the Comhairle, in writing, of the outcome of the consultation with the current organisations/users utilising the ground floor of the St Lennan's centre; and
- (3) in taking this decision, the Comhairle fully recognises the need to maximise any grant monies made available by the Scottish Government for the establishment of an Outer Hebrides Bairns Hoose whilst at the same time taking full account of the needs and requirements of current organisations/users of the ground floor of the St Lennan's centre.

Mr Paul Finnegan and Mr Paul Steele indicated that they were happy to accept the amendment as an addition to the recommendations at item 4 of the Decision Report.
