| ‘Shaping Our Future Service: Your Say’ SFRS Pre-Consultation – Report by Chief Executive | 5 (b) | The Chief Executive submitted a Report concerning the Comhairle’s draft response to the Scottish Fire and Rescue Service’s (SFRS) ‘Shaping Our Future Service: Your Say’ Public Pre-Consultation. The Report stated that the Scottish Fire and Rescue Service (SFRS) was undergoing a process of change as it developed into a thoroughly modern fire and rescue service, ready for the challenges of Scotland’s future. To deliver the best service to communities, the SFRS must have the right resources in the right place at the right time and, through this Pre-Consultation, the community was invited to comment on the SFRS’s plans going forward. |
