GAELIC LANGUAGE PLAN

7 Bòrd na Gàidhlig Strategic Stream Funding

The Chief Executive submitted a Report which provided information on funding which the Comhairle had received from Bòrd na Gàidhlig's Strategic Stream Fund. The Report stated that the Comhairle had been one of six local authority areas invited by Bòrd na Gàidhlig to submit an application to its Strategic Fund Stream fund on the basis of three year funding, to 1 November 2027, for the delivery of Gaelic development projects and it was intended that these projects would assist in the implementation of the National Gaelic Language Plan and the local authorities' own Gaelic Language Plans. The Report further stated that the Comhairle had awarded a total of £157,500 over three years for the delivery of two projects and these projects were detailed in paragraphs 6.1 and 6.2 of the Report.

It was agreed to recommend that the Comhairle note the Report.

8 Cuidih Mi! Gaelic Language Online Support Service

The Chief Executive submitted a Report which provided information about an integral Gaelic language support initiative for Comhairle nan Eilean Siar staff, which is aimed at increasing Gaelic capacity across all Comhairle departments, in line with the Comhairle's Gaelic First Policy and more details on the initiative are provided at paragraph 6.1 of the Report.
