



PLAYPARK AND PLAY AREA UPDATE

Report by Director of Education and Children's Services

PURPOSE OF REPORT To update Members on the outcome of Play Area/Playpark consultation and to recommend areas for development in consultation with communities and when funding is available.

COMPETENCE

- 1.1 There are no legal, financial, equalities or constraints to the recommendation being implemented.

SUMMARY

- 2.1 The Education and Children's Services Department undertook an on-line community evaluation to identify which play areas would be supported by communities as priorities for development and/or community consultation. A sum of £100k is available for investment in the 2017/18 budget.
- 2.2 Sport and Health used this data with previous data and community knowledge and are proposing the areas highlighted be prioritised by the Comhairle for refurbishment as appropriate and when funding is available.
- 2.3 It is recommended that the Comhairle Play Areas not highlighted be dismantled. Where the play area is managed by a community, they are notified that it is their sole responsibility for maintenance. Where no ownership can be determined and play area/equipment is not prioritised or is in poor condition it will be dismantled.
- 2.4 Future development would be determined by the priority and funding made available in the Comhairle's Capital budget or through external or partnership funding secured through community partnership.
- 2.5 The Play Areas highlighted in green are those prioritised for retention and funding. The development of play areas is also a good fit with the outcome of the Place Stand Tool survey for the OHCPP Local Improvement Plan which prioritised play and recreation and use of outdoor space. The Department of Education, Sport and Children's Services will work through the relevant priority group to achieve the agreed actions.

RECOMMENDATION

- 3.1 **It is recommended that the Comhairle note the report and approve the list of Play Areas Highlighted in green at Appendix 1 for retention and maintenance when additional funding is available and in partnership with community groups as appropriate.**
