**(SPACES FOR PEOPLE - 20MPH SPEED LIMIT)
EXPERIMENTAL ORDER 2021**

Comhairle nan Eilean Siar proposes to make "The Comhairle nan Eilean Siar (Stornoway) (Spaces for People – 20mph Speed Limit) Experimental Order 2021" under the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit any person from driving or causing or permitting to be driven, for a period of 12 months, any vehicles at a speed exceeding 20mph on the following roads within the Stornoway area:
