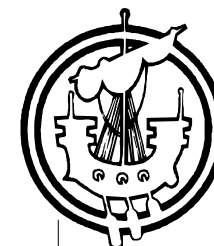

Building Standards

Does An Agricultural Building Require Planning Consent or a Building Warrant?



The purpose of this leaflet is to provide additional guidance on whether or not you require Planning Consent or a Building Warrant for the construction of an agricultural building.

General Information

If after consulting this guide you are still unclear as to whether or not your works require Planning Consent or a Building Warrant, please contact the local Planning & Building Standards Section for further guidance.

Planning Permission

All agricultural buildings must apply for Prior Notification. The form for which can be found on the CNES website at:

Some agricultural buildings will require a full planning application. The requirement for a full planning application applies if:

- The proposed building is to have a floor area in excess of 465m²;
- The building is to be located within 3km of the perimeter of an aerodrome and would exceed 3m in height;
- The building would exceed 12m in height;
- The building would be within 25 metres of the metalled portion of a trunk or classified road;
- The building is to be used for the purpose of housing pigs, poultry, rabbits, or animals bred for their skin or fur or for the storage of slurry or sewage sludge, and the building would be located within 400m of any protected building.

Please Note:

Some locations may have restricted development rights. Please contact the local Planning Service for advice, as it could be the case that there may be a restriction which does not permit the erection of new buildings beside your property.

Building Warrant

A Building Warrant is not required for the erection of an agricultural building* if the building:

- is detached and single storey;
- is not to be used to any extent for retailing (including storage for retailing) or exhibiting;
- does not exceed 280m² in area;
- is to be located on agricultural land or a croft;
- is not to be located less than 6m or the **height of the building (whichever is less) of a boundary;
- Is not a dungstead or farm effluent tank

* Agriculture is defined as in the Agriculture (Scotland) Act 1948 and 'agricultural' shall be construed accordingly.

** The height of the building is defined as the height halfway between the wallhead and ridge as shown in the diagram below

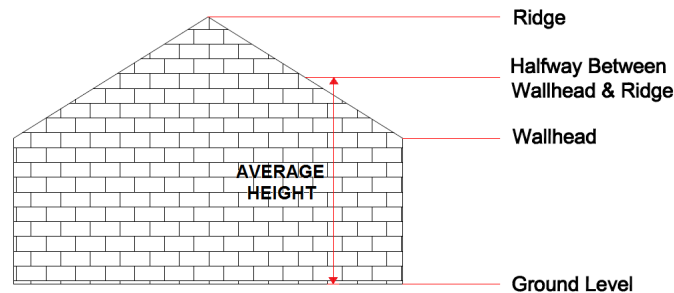
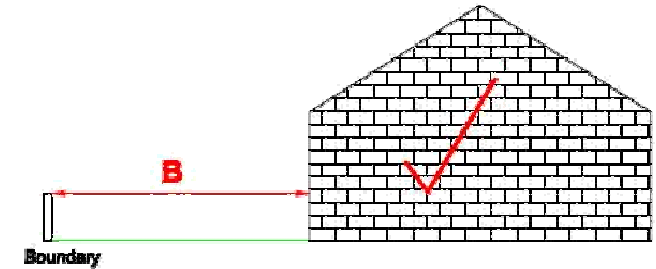
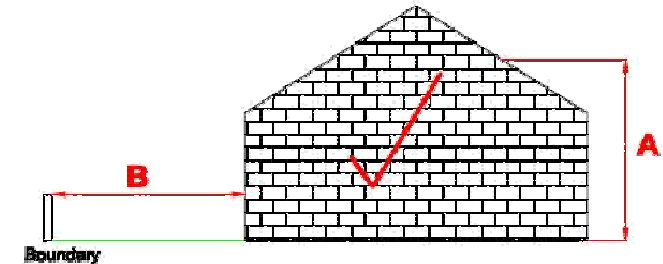


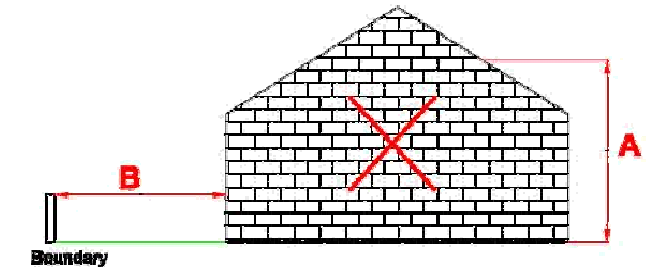
Diagram Notes: Dimension B is the distance to the boundary & Dimension A is the height from ground level to halfway between the wallhead and ridge.



If, as above, 'B' is greater than 6 meters then a building warrant MAY not be required.



If, as above, 'B' is less than 6 meters but more than 'A' then a building warrant MAY not be required.



If, as above, 'B' is less than 6 meters and less than 'A' then a building warrant WILL be required.

Please Note:

If you require written confirmation of whether or not your agricultural building requires a building warrant you can apply for this using an enquiry form available from the Development Department reception areas or by post upon request.
