Population and Migration

The Registrar General's Annual Review of Scotland's Population

“[Scotland's Population 2008](#): The Registrar General's Annual Review of Demographic Trends” was published on 7 August 2009. Although Scotland's population continues to rise the population of the Outer Hebrides has done down by 5% in the ten years from 1998 to 2008, one of three council areas with the highest reduction in population. Other key findings are:

- Overall population estimated to be 26,200, a decrease of 100 persons since 2007 (-0.4%)
- For the first time in a number of years there was negative net migration (-1)
- There were 256 births and 346 deaths
- There were 109 marriages and no civil partnerships

Migration

[Local area migration reports](#) are now available from the General Register Office for Scotland (GROS). Migration is the most difficult component of population change to estimate. These reports have been produced to facilitate analysis of migration trends at local authority level.

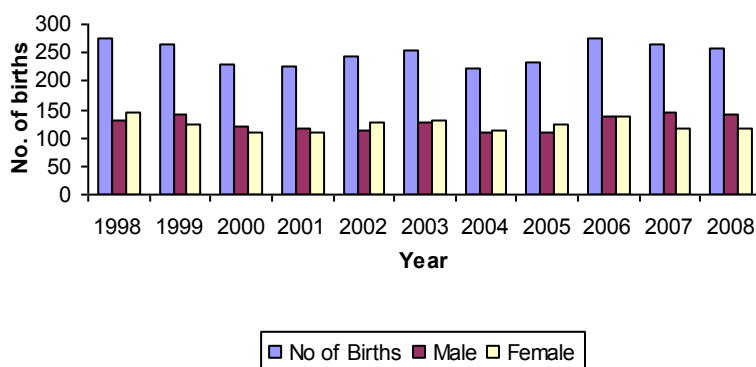
Household Estimates

The current [Household Estimates 2008](#) (released on 14 May 2009) identify an increase of 110 households (0.9%) since 2007; this is in line with the national trend (0.8%). The areas with the greatest increases over the last five years have been Highland (8.5 per cent) and Aberdeenshire (8.3 per cent). The area with the smallest change was Inverclyde.

Of all 32 Scottish Local Authorities areas, the Outer Hebrides is estimated to have; the highest % of detached dwellings at 64% (nat.avg.21%); the lowest % of occupied dwellings at 87% (nat avg 96%); the highest % of vacant dwellings at 7.1% (nat avg 2.8%); the second highest % of holiday homes at 6.2% of all dwellings (Argyll & Bute have the highest at 8.3%, nat avg 1.4%); the lowest % of dwellings with occupied exemptions at 0.6% (nat avg 2.5%); the highest % of houses in Council Tax Band A-C at 81% (nat avg 62%); the second lowest % of houses in Council Tax band D-E at 18% (Inverclyde lowest at 16%, nat avg. 26%); the lowest % of houses in Council Tax band F-H at 1% (nat avg. 12%).

Births Trend

Births in Outer Hebrides from 1998 to 2008



[GROS Vital Events](#) show that over the years 1998 to 2008 births in the Outer Hebrides have varied from a total of 223 in 2004 to a total of 274 in the years 1998 and 2006.

Over that time period 46 more males than females have been born.

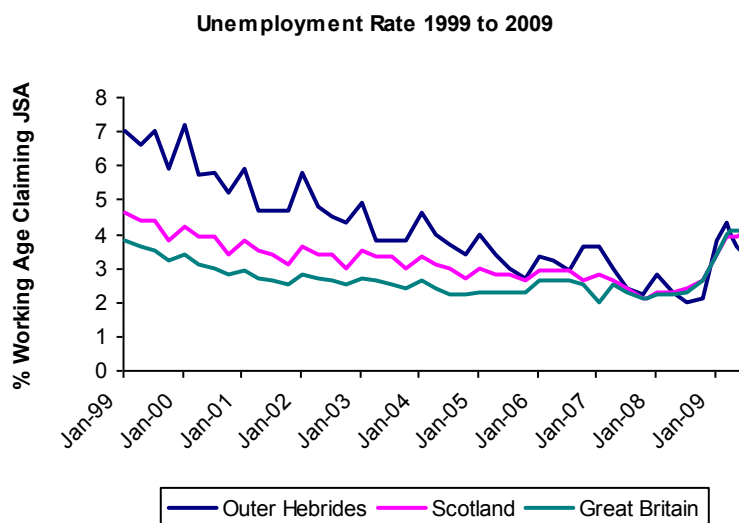
GROS figures for the first quarter of 2009 show that the Outer Hebrides is following the trend for Scotland as a whole. Births and deaths are lower than for the first quarter of 2008.

Labour Market

The latest release from [NOMIS](#) (Office for National Statistics) gives the following unemployment rates for July 2009:

Outer Hebrides	3.4%
Scotland	4.1%
Great Britain	4.1%

Since March 2009 the unemployment rate has decreased slowly each month. The Outer Hebrides now has a lower unemployment rate than Scotland and Great Britain.

Health Care & Welfare

The latest statistics reveal that island NHS boards (Western Isles, Orkney and Shetland) had the lowest abortion rates in Scotland in 2008 at 5.7. Western Isles NHS Board also had the lowest teenage pregnancy rate in 2007 for under 18 and the second lowest teenage pregnancy rate for under 20 (Shetland had the lowest).

A study by the Joseph Rowntree Foundation has highlighted a worrying trend in the United Kingdom that although young men are binge-drinking less, women are binge-drinking more. According to a new report by the Chartered Society of Physiotherapy only 10% of people in Scotland know how much exercise they need to take each day.
