## ROAD TRAFFIC REGULATION ACT 1984

### COMHAIRLE NAN EILEAN SIAR (OFF-STREET) PARKING PLACES (PAY & DISPLAY) ORDER 2017

Comhairle nan Eilean Siar in exercise of its powers under sections 9 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as “the 1984 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

#### **PART 1: COMMENCEMENT & INTERPRETATION**

##### **Citation and Commencement**

- 1 This Order may be cited as “The Comhairle nan Eilean Siar (Off-Street) Parking Places (Pay & Display) Order 2017” and shall come into operation on *[date]*

##### **Interpretation**

- 2 (a) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them: -
  - (i) “agricultural vehicle” means a vehicle which is constructed or adapted for use for the purpose of agriculture, horticulture or forestry and which is primarily used for one or more of those purposes;
  - (ii) “appropriate fee” means the sums of money due in respect of any paid period and shall be as described in the schedule to this Order in respect of each parking place;
  - (iii) “Article” means an Article of this Order;
  - (iv) “bus” means any motor vehicle which is constructed or adapted to carry more than sixteen seated passengers in addition to the driver;
  - (v) “caravan” has the meaning as prescribed to it in section 29 of the Caravan Sites and Control of Development Act 1960;
  - (vi) “car park attendant” means a person authorised by or on behalf of the Comhairle to supervise any off-street car park;
  - (vii) “charging day” means every day except Sundays, Christmas Day and Boxing Day, and the First and Second days of January in any year;
  - (viii) “charging hours” means the period between 9 am and 6 pm on a charging day;
  - (ix) “Comhairle” means Comhairle nan Eilean Siar; where reference in this order is made to the Comhairle taking any action, for the evidence of doubt this will be deemed to include actions of any person or other agency taking the action specified on behalf of the Comhairle having been duly authorised by the Comhairle so to do.
  - (x) “cycle parking place” means any part of a parking place authorised for use as a parking place for motor cycles not having a sidecar attached thereto;

- (xi) "disabled person's badge" has the same meaning as prescribed to it in of The Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000;
- (xii) "disabled person's vehicle" has the same meaning as prescribed to it in Regulation 2 (1) of The Local Authorities' Traffic Order (Exemptions for Disabled Persons) (Scotland) Regulations 1991;
- (xiii) "driver", in relation to a vehicle left in a parking place, means the person driving the vehicle at the time it was left in the parking place;
- (xiv) "engineering plant" has the same meaning as in the Road Vehicles (Construction and Use) Regulations 1986;
- (xv) "Fixed Penalty" means a Notice applied in terms of this Order;
- (xvi) "goods" includes postal packets of any description; and "delivering" and "collecting" in relation to any goods include checking the goods for the purpose of their delivery or collection and loading the goods on to or unloading the goods from a vehicle;
- (xvii) "goods vehicle" means a motor vehicle or trailer which is constructed or adapted for use for the carriage or haulage of goods or burden of any description;
- (xviii) "heavy commercial vehicle" means any goods vehicle which has an operating weight exceeding 7.5 tonnes, and "operating weight" has the same meaning as in section 138 (2) of the Act;
- (xix) "industrial vehicle" means a mechanically propelled vehicle which is designed and used primarily for work off roads, or for work on roads in connection only with road construction or maintenance;
- (xx) "invalid carriage" has the same meaning as in section 136 of the Act;
- (xxi) "loading area" means any area forming part of a parking place and set apart for use as a place where vehicles may be driven and parked for the sole purpose of being loaded or unloaded in connection with a trade or business carried on in premises adjoining the parking place;
- (xxii) "maximum stay" refers to the maximum period a vehicle can be parked within a parking place within the charging hours on any charging day as specified in the schedule(s) annexed hereto, specifying the provisions for the particular parking place.
- (xxiii) "motor cycle" has the same meaning as in section 136 of the 1984 Act;
- (xxiv) "owner" in relation to a vehicle, means the person by whom such vehicle is kept and for the purpose of determining, in the course of any proceedings brought by virtue of section 35A (1) of the 1984 Act, who was the owner of a vehicle at any particular time, it shall be presumed that the owner was the person in whose name the vehicle was at that time registered under the Vehicles (Excise) Act 1971;
- (xxv) "paid period" refers to the period of time specified on any parking ticket;
- (xxvi) "parking bay" means an area of a parking place (other than a cycle parking place) which is provided for the leaving of one vehicle and indicated by markings on the surface of the parking place;
- (xxvii) "parking place" means an area of land including accesses and exits designated as a parking place by Article 3 of this Order;

- (xxviii) "parking ticket" means a ticket issued by a parking ticket machine installed at a parking place, in respect of a payment of the appropriate fee.
- (xxvii) "passenger vehicle" means a motor vehicle (other than a bus or caravan or motor cycle or invalid carriage) constructed solely for the carriage of persons and their effects and which is not drawing a trailer:
- (xxviii) "public works vehicle" has the same meaning as in the Road Vehicles (Construction and Use) Regulations 1986:
- (xxix) "relevant position means:
- (A) where the vehicle is fitted with a dashboard or fascia panel in a conspicuous position thereon;
  - (B) in the case of a vehicle not fitted with a dashboard or fascia panel in a conspicuous position on the vehicle;
- (xxxi) "telecommunications apparatus" has the same meaning as in Schedule 2 to the Telecommunications Act 1984;
- (xxxii) "the Act" means the Road Traffic Regulation Act 1984 as amended;
- (xxxiii) "traffic warden" has the same meaning as in section 95 of the Act;
- (xxxiv) "trailer" includes any vehicle drawn by a motor vehicle;
- (xxxv) "tricycle" includes a cycle which is not a motor vehicle and has three or more wheels;
- (xxxvi) "vehicle" means any vehicle, whether or not it is in a fit state for use on roads, and includes chassis or body, with or without wheels, appearing to have formed part of such a vehicle, and any load carried by, and anything attached to, such a vehicle;
- (xxxvii) "works trailer" and "works truck" have the same meanings prescribed to them as in the Road Vehicles (Construction and Use) Regulations 1986.
- (b) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- (c) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.

## **PART 2: GENERAL**

### **Application of Order to Parking Places**

- 3 The provisions of this Order shall apply to the following area(s) of land in Stornoway more particularly described in the corresponding Schedule(s) to this Order and shown shaded as described, on the plan(s) annexed and executed as relative hereto:
- (a) Perceval Square Car Park & Fisherman's Car Park, Stornoway (Schedule 1)
  - (b) South Beach Area A, Stornoway (Schedule 2)
  - (c) South Beach Area B, Stornoway (Schedule 3)

### **Number and Situation of Parking Bays**

- 4 The number and situation of parking bays in any parking place shall be as may be determined from time to time by the Comhairle.

### **Limit of Parking Bays**

- 5 The limits of any parking bay in a parking place shall be indicated in such a manner as the Comhairle may determine by lines, studs or other markings.

### **Vehicles for which the Parking Places are Designated**

- 6 (a) Each parking place may be used subject the provisions of this Order for the leaving such vehicles as are passenger vehicles, motor cycles, tricycles, invalid carriages, and goods vehicles which are not heavy commercial vehicles, provided any vehicle left in a parking place is not drawing a trailer.
- (b) Agricultural vehicles, caravans, engineering plant, heavy commercial vehicles, industrial vehicles works trailers and work trucks shall be prohibited from using the parking places at any time.

### **Maximum Period of Waiting**

- 7 Subject to the provisions of Article 14 of this Order, no vehicle may be left in any parking bay during charging hours for a single stay exceeding the maximum stay period specified in the schedule(s) annexed and subscribed as relative hereto for a parking place.

- 8 In any civil proceedings for the recovery of costs under Article 13 of this Order or any criminal proceedings for any contravention of or non-compliance with any provision of this Order, the paid period indicated by the parking ticket exhibited on a vehicle left in a car park shall be sufficient evidence of the time the vehicle should have left the car park.

- 9 Notwithstanding the provisions of Article 7 of this Order the driver of a vehicle which is left in a car park shall be liable to a Fixed Penalty in either of the following circumstances:

- (a) Failure to exhibit a valid Parking Ticket on the vehicle in accordance with Article 20 of this Order;
- (b) Remaining in the parking place for a period in excess of the paid period;
- (c) During the charging day return of the vehicle to a parking place within 2 hours of the last period of parking of the vehicle in that parking place.

- 10 Where a vehicle is observed by any person duly authorised by the Comhairle for the purpose, which may include but is not restricted to a police officer, traffic warden or parking attendant within a parking place in any of the circumstances given rise to a charge specified in Article 7 or 20 of this Order, he shall affix to the outside of the windscreen, or any prominent part of the vehicle a Fixed penalty Notice, which will specify the following:

- (1) The date and time of the observation and the date and time of the issuing of the notice.
- (2) The car park and (if appropriate) the parking bay number in which the vehicle is parked.
- (3) The make, model, colour and registration mark of the vehicle.
- (4) Which of the circumstances in Article 11 of this Order give rise to the charge.
- (5) The amount of the charge.
- (6) A statement that:
- (a) The charge is payable by the driver of the vehicle.

- (b) The time within which payment of the charge is to be made and the address at which payment is to be made.
  - (c) Failure to pay the charge is an offence in terms of Section 35A(1) of the Act.
  - (d) Once the person authorised to do so has affixed a notice of charge to a vehicle it shall be an offence to fail to remove the vehicle from the car park by midnight on the date of issue of the said notice of charge. The Comhairle may, after that time remove the vehicle from the car park and recover by civil proceedings the cost of so doing from the owner.
11. Where a fixed penalty is incurred in any of the circumstances specified in Article 10 it shall be payable within 21 days to the Comhairle by cash, cheque or postal order, delivered or sent by post to the Comhairle at the address specified on the notice of charge.
12. The driver shall remove from the parking place before midnight on the date of issue of the notice aftermentioned the vehicle to which has been affixed a fixed penalty. Notwithstanding the foregoing if the driver fails so to remove the vehicle the provisions of this Order will continue to apply to the driver and the vehicle.
13. Where a vehicle remains within a car park after midnight on the date of issue of a fixed penalty which has been affixed to the vehicle and notwithstanding the terms of Article 17 (e) the Comhairle may remove the vehicle from the parking place to a safe place, and recover as a civil debt from its owner the cost of so doing. The Comhairle may refuse to return the vehicle to its owner without first receiving payment of such costs.

#### **Exemptions from Charges and Time Limits**

14. Nothing in Article 7 and 9 of this Order shall apply:
- (a) If, at the time when a vehicle is left in a parking place during charging hours, there is no parking ticket machine at the parking place or there is on all the parking ticket machines at the parking place a notice placed by the Comhairle indicating that the parking ticket machines are out of order, that vehicle shall be exempt from payment of an initial charge under Article 20 of this Order provided that the vehicle (i) is not left for a period exceeding three hours in the parking place after any of the machines is rectified and (ii) has not within the initial period previously been left in another parking place, and all the provisions of this Order shall apply accordingly.
  - (b) Any disabled persons vehicle displaying a disabled persons badge, as defined by the Local Authorities Traffic Orders (Exemption for Disabled Persons (Scotland) Regulations 2002 so long as that badge is displayed in the relevant position and has been issued by the Local Authority in exercise of its powers under section 21(1) of the Chronically Sick and Disabled Persons Act 1970 and the vehicle is not causing an obstruction.
  - (c) A vehicle which is left in a parking bay designated for permit holders shall be exempt from payment of an initial charge under Article 20 and from compliance with the provisions of Article 7 of this Order as provided for by Article 25 of this Order.
  - (d) A vehicle used for fire brigade purposes, an ambulance or a vehicle in the service of a police force, in each case being used in pursuance of statutory powers or duties, shall be exempt for the provisions of this Order.
  - (e) A vehicle (other than as a bus passenger vehicle) in the service of a local authority or statutory undertaker, in each case being used in pursuance of statutory powers and duties, exempt from the provisions of this Order provided a valid parking permit issued by the Council's Chief Executive is displayed conspicuously on the vehicle with the obverse side facing forward on the nearside of the inside surface of the front windscreen or, if the vehicle is not fitted with a front windscreen, on the nearside of the vehicle.
  - (f) A vehicle using any roadway or any loading area in a parking place for delivering goods to or collecting goods from, or for the servicing of, businesses and commercial premises

adjoining the parking place shall be exempt from payment of an initial charge under Article 20 of this Order, but otherwise all the provisions of this Order shall apply.

- (g) A vehicle which is left in the loading area situated in any parking place named in the Schedule hereto shall be exempt from payment of an initial charge under Article 20 of this Order.
- (h) Any vehicle which is being used to enable a person to board or alight from the vehicle.
- (i) Any vehicle being used to enable goods to be loaded on to or unloaded from a vehicle.

### **Use of Parking Places**

- 15
- (a) The driver of a vehicle shall not permit that vehicle to wait in a parking place unless the vehicle displays a valid licence issued in accordance with the provisions of section 1 of the Vehicles (Excise) Act 1971 and unless there is in relation to the use of the vehicle by the driver such a policy of insurance as complies with the requirements of Part VI of the Road Traffic Act 1988.
  - (b) No person shall, without the prior written permission of the Comhairle, use any part of parking place or any vehicle while it is in a parking place in connection with the sale or distribution of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skills or services.
  - (c) No person shall use any part of a parking place or any vehicle left in a parking place –
    - (i) for sleeping or camping or cooking; or
    - (ii) for the purpose of servicing, repairing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to be moved from the parking place.
  - (d) No person shall leave a broken down vehicle in a parking place.
  - (e) No person shall in a parking place –
    - (i) erect or cause or permit to be erected any tent, booth, stand, building, or other structure without the prior written permission of the Comhairle;
    - (ii) light or cause or permit to be lit any fire;
    - (iii) play games;
    - (iv) throw down, drop or otherwise deposit in, into or from the parking place and leave anything whatsoever so as to cause the defacement by litter of the parking place.
  - (f) Notwithstanding the terms of Article 17(e), the Comhairle does not accept any liability for death or personal injury or loss suffered by any person within any parking place or for loss of or damage to a vehicle left in or otherwise using a parking place or moved in to or removed from a parking place in terms of Article 15 of this Order nor for the loss or damage to or any item, equipment or goods left in or upon such vehicle.

### **Manner of Standing in the Parking Places**

- 16
- (a) Every vehicle left in a parking place, shall so stand that every part of the vehicle is within the limits of a parking bay and no vehicle shall be left in a parking place other than within the limits of a parking bay.
  - (b) The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in the position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.

- (c) The driver of a vehicle using a parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in or to depart from the parking place and then only if necessary in the interests of road safety.
- (d) No vehicle, other than a disabled person's vehicle shall be left in any parking bay designated for the use of a disabled persons vehicle.
- (e) No vehicle shall be left in any parking bay designated for the use of permit holders unless a valid permit issued by the Comhairle's Chief Executive is conspicuously displayed with the obverse side facing forward on the nearside of the inside surface of the windscreen or, if the vehicle is not fitted with a front windscreen in a conspicuous position on the nearside of the vehicle.

#### **Alteration of Position of Vehicle in a Parking Place or Removal of Vehicles from a Parking Place**

- 17
- (a) Where any vehicle is standing in a parking place in contravention of the provisions of Article 16 of this Order the Comhairle may move the vehicle or cause it to be moved to a position where it shall comply with those provisions.
  - (b) Where the Comhairle is of the opinion that a vehicle has been left in a parking place in a contravention of or non-compliance with the provisions of this Order, it may make arrangements to remove the vehicle, or cause it to be removed from the parking area.
  - (c) In case of emergency the Comhairle may move or cause to be moved to any place he thinks fit a vehicle left in a parking place.
  - (d) Any person altering, or causing alteration of, the position of a vehicle by virtue of a paragraph (a) of this Article, or removing, or causing the removal of, a vehicle by virtue of paragraphs (b) or (c) of this Article, may do so by towing or driving the vehicle or in such other manner as he may think reasonably necessary to enable the position of the vehicle to be altered or the vehicle removed.
  - (e) Any person removing or arranging for the removal of a vehicle by virtue of paragraphs (b) or (c) of this Article shall do so to an appropriate place having regard to the safety of the vehicle in the place to which it is removed.

#### **Driving within Parking Places**

- 18
- (a) No person shall cause or permit any vehicle to enter the car park otherwise than by an entrance or leaving the car park otherwise than by an exit, so indicated.
  - (b) No person shall drive or cause or permit to be driven any vehicle within the car park otherwise than in the directions indicated by the road signs or road markings.

#### **Power to Suspend Parking Places**

- 19
- (a) Any person duly authorised by the Comhairle may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary (i) for the purpose of facilitating the movement of traffic or promoting its safety; or (ii) for the purpose of any building operation, demolition or excavation adjacent to the parking place or the laying, erection, alteration or repair in or adjacent to the parking place of any sewer or any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication apparatus, or of any traffic sign.
  - (b) On any suspension of the use of a parking place or any part thereof in accordance with the provisions of the last paragraph any person duly authorised by the Council shall use suitable means to indicate that the use of the parking bay or parking place is suspended.

## Initial Charges

- 20 (a) Subject to the provisions of Articles 6, 7 and 14 of this Order, an initial charge shall be payable in respect of any vehicle in a parking place during charging hours.
- (b) (i) The initial charge for a vehicle in any parking place shall be as provided in the corresponding Schedule for that parking place as described in Article 3 of this Order as annexed and subscribed as relative hereto.
- (ii) The charges referred to in 20(b)(i) above apply in each case to an individual ticket purchased for, and valid for, a stay in a parking bay in one of the parking places specified in the schedule(s) to this Order but subject always to the provisions of Article 7 of this Order. Each charge shall apply to a ticket expiring at the end of the paid period (whether one hour or two hours or three hours). The expression "paid period" refers to the expiry of either one hour or two hours or three hours, measured in terms of a period, or periods, of charging hours and not including any length of time outwith charging hours.
- (iii) Parking Tickets purchased are valid only on the day of purchase, regardless of whether the paid period extends beyond charging hours; the maximum stay period refers to the maximum period a vehicle can be parked within a parking place within the charging hours on any charging day as specified in the schedule(s) annexed hereto, specifying the provisions for the particular parking place.
- (c) The initial charge shall be payable on leaving the vehicle in a parking bay by insertion of one or more coins in a parking ticket machine situated in the parking place in which the vehicle is first left, and evidence of the payment shall be the issue of a ticket by the parking ticket machine in terms of this Order and the exhibition of that ticket in accordance with the provisions of this Article.
- (d) The ticket referred to in paragraph (c) of this Article shall be exhibited on the vehicle –
- (i) in the case of a two-wheeled motor cycle having a sidecar attached thereto, in a conspicuous position on the nearside of the vehicle in front of the driving seat;
- (ii) in case of all other vehicles –
- (a) where the vehicle is fitted with a front glass windscreen extending across the vehicle to the nearside, facing forwards on the glass of such windscreen immediately behind the glass;
- (b) where the vehicle is not fitted with a front glass windscreen as specified in preceding sub-paragraph, on the nearside of the vehicle facing towards the nearside of the road and not less than seventy six centimetres and not more than two metres above the surface of the carriageway in the immediate vicinity.
- (e) Not more than one ticket shall be exhibited on any vehicle at any one time.
- (f) A ticket, while exhibited on the vehicle, shall be so placed that the time shown on the front of the said ticket is clearly visible to a person standing at the nearside of the vehicle.
- (g) No person shall knowingly exhibit on any vehicle any ticket which had been altered, defaced, mutilated or added to or upon which the figures or particulars have become illegible.
- (h) No person shall exhibit on any vehicle any ticket which has previously been exhibited on any other vehicle.
- (i) When a ticket is exhibited in pursuance of this Order on a vehicle waiting in a parking place the time indicated by the ticket showing the termination of that periods shall be treated as evidence that the vehicle has been waiting in the parking places for the permitted period up to the time shown on the ticket in any proceedings for an offence under this Order.



- 21 The initial period for which a vehicle may be left in any parking place during charging hours shall be one of the paid periods specified in paragraph (b) of Article 20 of this Order.

### **Excess Charges**

22 A Fixed Penalty shall be applied:-

- (a) If a vehicle is left in a parking place during charging hours for any period in excess of the initial period (one hour or two hours or three hours) for which payment was made by an initial charge;
- (b) If a vehicle is left in a parking place -
  - (i) at any time in contravention of the provisions of Articles 6, 7, 8, 9 or 11 of this Order, or
  - (ii) during the charging hours and subject to the provisions of Articles 14 of this Order without evidence of payment of the initial charge in accordance with the provisions of Article 13 of this Order.

### **Notice of Charge**

23 In the case of a vehicle in respect of which an excess may have become payable in terms of Article 15 of this Order, it shall be the duty of the Comhairle to attach to the vehicle in a conspicuous position a notice which shall include the following particulars:-

- (a) the registration mark of the vehicle or, where the vehicle is being used under a trade licence, the number of the trade plate carried by the vehicle;
- (b) the time at which the first noticed (i) that the initial charge had not been paid or (ii) that, the initial charge having been paid, the ticket obtained from the parking ticket machine had not been exhibited on the vehicle in accordance with the provisions of Article 13 of this Order or (iii) that the vehicle had been left in the parking place for longer than the period (one hour or two hours or three hours) for which payment of the initial charge had been made or (iv) that the vehicle had been left in the parking place in contravention of some other provision of this Order;
- (c) the name of the parking place;
- (d) if any ticket exhibited on the vehicle has been issued by a parking ticket machine situated in another parking place, the name of that parking place;

### **Restriction of Removal of Notice and Tickets**

24 (a) When a ticket has been exhibited on a vehicle in accordance with the provisions of Article 13 of this Order no person, other than the driver of the vehicle, shall remove the ticket from the vehicle unless authorised to do so by the driver.

(b) Where a notice has been attached to a vehicle in accordance with the provisions of Article 17 of this Order, no person other than a police constable in uniform, a car park attendant, the driver of the vehicle or a person authorised by the driver in that behalf shall remove the notice from the vehicle.

### **Parking Permits**

25 A vehicle which has been left in a parking bay designated for the use of permit holders and on which there is displayed in accordance with the provisions of Article 20(d) of this Order a

valid parking permit issued by the Comhairle shall be exempt from compliance with the provisions of Article 7, but otherwise all the provisions of this Order shall apply.

**Parking Ticket Machines**

26 The Comhairle may install and maintain in such positions as it thinks fit or in the the vicinity of a parking place such parking ticket machines as may be required.

**Traffic Signs etc**

27 The Comhairle may –

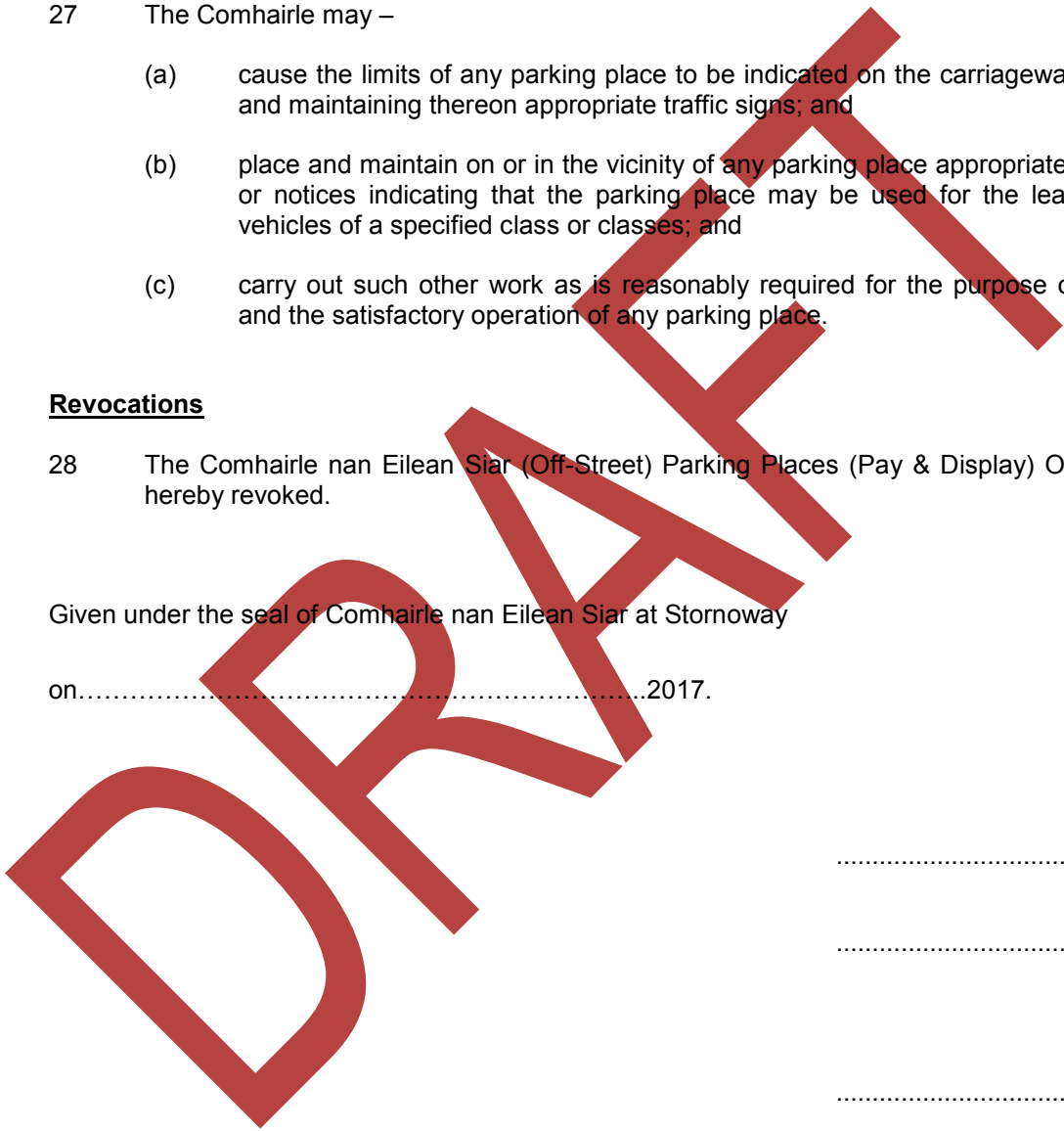
- (a) cause the limits of any parking place to be indicated on the carriageway by placing and maintaining thereon appropriate traffic signs; and
- (b) place and maintain on or in the vicinity of any parking place appropriate traffic signs or notices indicating that the parking place may be used for the leaving only of vehicles of a specified class or classes; and
- (c) carry out such other work as is reasonably required for the purpose of this Order and the satisfactory operation of any parking place.

**Revocations**

28 The Comhairle nan Eilean Siar (Off-Street) Parking Places (Pay & Display) Order 2006 is hereby revoked.
