



## ROAD TRAFFIC REGULATION ACT 1984

### COMHAIRLE NAN EILEAN SIAR STORNOWAY TOWN CENTRE (PROHIBITION OF WAITING) ORDER 2008 AMENDMENT (NO 2) ORDER 2016

TRO-16/02

Comhairle nan Eilean Siar proposes to make "The Comhairle nan Eilean Siar (Stornoway Town Centre) (Prohibition of Waiting) Order 2008 Amendment (No 2) Order 2016 under the Road Traffic Regulation Act 1984.

The effect of the amendments will be to extend or remove waiting restrictions which were promoted in the original order. This also includes the introduction of a one way system all as summarised below:

**Bayhead Street** – Layby between roundabout and Stag Road junction.  
The effect of the Order will be to remove the existing restriction.

**Bayhead Street** – Layby between Stag Road junction and old Dentist building.  
The effect of the Order will be to remove the existing restriction.

#### **Church St / Elizabeth Haldane Court**

Introduce a "No Waiting At Any Time" parking restriction to the junction with Elizabeth Haldane Court. This restriction will be extended on the West side for a length of 30m.

#### **Church Street**

Extend the "No Waiting At Any Time" parking restriction to cover both sides of Church Street between Cromwell Street and Kenneth Street.

#### **Cromwell Street**

Extend the "No Waiting At Any Time" parking restriction by 10m from the junction with Scotland Street.

#### **Francis Street**

Extend the existing "No Waiting At Any Time" on the North side of Francis Street, East of the Lewis Street junction.

#### **Kenneth Street**

Extend the "No Waiting At Any Time" parking restriction on the West side of Kenneth Street.

#### **South Beach Quay**

Extend the "No Waiting At Any Time" parking restriction to the rear of the bus station. This will run on both sides of the road from the "Herring Girl" statue to the Cal Mac "Long Stay" car park.

A section of the road, known as South Beach Quay, will become a one way street operating in one way direction from the "Herring Girl" statue to the Cal Mac "Long Stay" car park.
