From community perspective, decreases in FiTs make the installation of micro-renewables less viable, but work on local energy supply, smart controls, and the possibility of receiving grant-funding rather than FiTs mean that groups are still interested in micro-renewables; particularly wind turbines, solar panels and heat pumps.
Highlight inequality in electricity costs in the Outer Hebrides and seek to address this.	Lobby electricity energy companies, OFGEM/DECC to address issues related to competition and pricing in the local electricity market.	All	Comhairle monitoring extent to which recommendations in CMA investigation into the UK Energy Market are progressed. One of the most significant impacts has been the price cap on pre-payment tariffs. In context of increase in standard variable tariffs, this has meant these are now more in line with customers on credit meters. Removing the 4 tariff rule is also potentially beneficial to introduction of community tariffs in certain geographical areas. TIG & HHP attend HIHAAW group which is lobbying on these issues.
Support and promote energy switching among local consumers.	Identify the resources available to support Electricity Supplier switching and the service these resources provide Consider how the Action Group can promote switching (general awareness raising, working with target groups etc).	TIG/All	Information on local support for switching was collated, and meeting held to identify options for promoting these. TIG are developing on-line switching platform for local consumers (using same platform as Citrus Energy) so all partners in the Action Group can play role in supporting promotion of the energy and advice available through this. The platform is live but TIG is working with the operators to ensure accurate information can be given to gas customers in Stornoway.
Pursue creation of a community tariff for the Outer Hebrides.	Engage with electricity suppliers to invite proposals for community tariff as first stage in ESCO.	Comhairle	Procurement exercise and subsequent discussions with potential partner to see if other opportunities for community tariff exist. Comhairle are also now in dialogue with Orkney, Shetland and Highland Councils who are all looking at similar opportunities.
Pursue local electricity supply opportunities through creation of Outer Hebrides Energy Supply Company.	Improve links with local generators in order to develop local electricity supply as further development of ESCO.	Comhairle	Hebrides Energy CIC starting to look more proactively at these opportunities, including opportunity to directly invest in renewable schemes.
